# 3. Minutes of Last Meeting

The minutes of the last meeting were approved as a true record, save at paragraph 6, in relation to the Child Protection policy, it was proposed by Dane Butler. Subject to the amendments the minutes of the last meeting were approved as a true record proposed by Tony Baker and seconded by Kevin Matthews.

#### 4. Matters Arising

i. Tony Baker reported that as far as the CRB is concerned, the BCU are unclear about the portability of the CRB certificates. They confirmed it is up to the club as to whether we should accept certificates that are provided to other organisations. Their advice however, is that we should ensure that the CRB checks are carried out again. All present agreed that new applications would be made to the CRB for CRB check in respect of all of us. However, in the meantime, we would agree to accept the CRB that have been carried out on all coaches present, from other organisations. Tony Baker produced the application form and confirmed he was sorting out a guide to show us all how to complete it. He would forward the application form and the guide to us shortly.
